- Sections 38 of the *Health Professions Act* provides in part:

Discipline committee hearing

(6) The discipline committee may order a person to attend at a hearing to give evidence and to produce records in the possession of or under the control of the person.

(7) On application by the discipline committee to the Supreme Court, a person who fails to attend or to produce records as required by an order under subsection (6) is liable to be committed for contempt as if he or she were in breach of an order or judgment of the Supreme Court.

- Section 6.06(3) of the College's Bylaws provides:

(3) The registrar or the discipline committee must provide, by registered mail or by personal service, notice in Form 11 to a person who is required under section 38(6) or 47 of the Act to attend a hearing under section 38 or 44 of the Act.

- Sections 38 and 47 of the *Health Professions Act* provide in part:

Discipline committee hearing

(6) The discipline committee may order a person to attend at a hearing to give evidence and to produce records in the possession of or under the control of the person.

(7) On application by the discipline committee to the Supreme Court, a person who fails to attend or to produce records as required by an order under subsection (6) is liable to be committed for contempt as if he or she were in breach of an order or judgment of the Supreme Court.

Obligations to provide evidence respecting health profession corporation

47 A shareholder, director, officer or employee of a health profession corporation may be compelled in a proceeding under this Act . . . to give evidence and to produce all files and records in his or her possession or power that are relevant to a matter raised in the proceeding.
