- may use the title "denturist" and the terms "regulated", "registered" and "licensed", in full or as abbreviated, but
- must not
  - delegate any aspect of practice involving patient assessment or treatment,
  - vote or be elected in a board election,
  - vote at a general meeting of the College, or
  - be appointed to, or serve on, a committee established under the bylaws.

... a temporary registrant, for a period of up to 3 months,

- is entitled to practice denturism in the province of British Columbia, and
- may use the title "denturist" and the terms "regulated", "registered" and "licensed" in full or as abbreviated, but
- must not
  - vote or be elected in a board election,
  - vote at a general meeting of the College, or
  - be appointed to, or serve on, a committee established under the bylaws.

... a non-practicing registrant

- must not practice denturism in the province of British Columbia,

- may use the title “denturist” and the terms “regulated”, “registered” and “licensed” in full or as abbreviated, but only in association with the term “non-practicing” or the term “retired”, and
  - must not
    - vote or be elected in a board election,
    - vote at a general meeting of the College, or
    - be appointed to, or serve on, a committee established under the bylaws.
- ... an intern registrant
- is entitled to practice denturism in the province of British Columbia, but only under the supervision of an active full registrant,
  - may use the titles “intern denturist” and “denturist intern”, and
  - must not
    - delegate any aspect of practice involving patient assessment or treatment,
    - vote or be elected in a board election,
    - vote at a general meeting of the College, or
    - be appointed to, or serve on, a committee established under the bylaws.]
