## **MENTOR CONTRACT**

Between:

\_\_\_\_\_ (the “Mentor”)

and

\_\_\_\_\_ (the “Intern”)

WHEREAS the Mentor and the Intern have each read sections 4.02(1)(b) and 4.07, and Schedule B (the Internship Portfolio Requirements) of the College’s bylaws (the “Bylaws”);

AND the Intern wishes to complete an internship portfolio as part of an application for active full registration, and the Mentor is prepared to assist the Intern in doing so;

NOW, THEREFORE, the Mentor and Intern agree as follows:

1. Upon the Intern becoming an intern registrant, the Mentor and Intern will enter into an arrangement providing for the Intern to practice as an intern registrant under the Mentor’s supervision.
2. After commencing practice as a intern registrant under the Mentor’s supervision, the Intern will strive to complete in a timely manner all the intern requirements under sections 1 through 5 of Schedule B of the Bylaws.
3. At all times while an intern registrant, the Intern will abide by the provisions of the *Health Professions Act*, the regulations and the Bylaws, and in particular, will practice in accordance with the limits on intern practice under section 4.07(2), (3) and (6) of the Bylaws.
4. While the Intern is practicing as an intern registrant under the Mentor’s supervision,
  - (a) the Mentor will provide the Intern with a practice environment and experience suitable for the Intern to comply with paragraph 2, and
  - (b) the Mentor will not sign a Mentor Contract in support of another application for intern registration.
5. The Mentor will complete a mentor assessment of the Intern in accordance with the requirements of section 8 of Schedule B of the Bylaws.
6. This Mentor Contract will terminate and its provisions will have no further force and effect upon the occurrence of any one of the following:
  - (a) the cancellation of the Intern’s intern registration under section 4.07(4), (8) or (9) of the Bylaws;

- (b) the Intern delivering notice of cancellation of this Mentor Contract in writing to both the Mentor and the College;
- (c) the Mentor delivering notice of cancellation of this Mentor Contract in writing to both the Intern and the College;
- (d) the Mentor ceasing to be a registrant in good standing of the College.
